WHAT DOES THE FUND INVEST IN?

The objective of the Fund is to achieve long-term capital growth. It seeks a similar return to its underlying fund, Spratt Small Cap Equity Fund, by investing substantially all of its assets in securities of that fund. The underlying fund invests primarily in small capitalization equity and equity-related securities listed in Canada, with some exposure to global small capitalization equities.

HOW RISKY IS IT?

Like most mutual funds, this Fund does not have any guarantees. You may not get back the money you invest.

HOW HAS THE FUND PERFORMED?

This section tells you how the series has performed since inception. Returns are after fund expenses have been deducted. These expenses reduce the series returns. Returns are before any taxes you may incur. Your actual after-tax return will depend on your personal tax situation.

WHO IS THIS FUND FOR?

The Fund is suitable for those investors seeking long-term capital growth with a medium to high tolerance for risk and volatility, wanting to share in the opportunities offered by the growth potential of equity securities of primarily small capitalization Canadian companies. Investors should be investing for the longer term and it is appropriate if you have a long-term investment horizon.

! Don't buy this Fund if you need a steady source of income from your investments.

A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on the Fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series I shares of the Fund. The Fund has other series. The fees and expenses are different for each series. Ask your Adviser about other series that may be suitable for you.

1. Sales Charges

There are no sales charges in connection of the purchase of these shares.

2. Fund Expenses

The series' expenses are made up of the management fee, operating expenses and trading costs. The series' annual management fee is negotiated by the shareholder and would not exceed 2.50%. Because this mutual fund is new, information on the operating expenses and trading costs for this series is not yet available. You don't pay these expenses directly. They affect you because they reduce the series' returns.

Incentive Fee

No incentive fee is paid directly by the Fund. However, the underlying fund in which the Fund invests pays us annually an incentive fee. The incentive fee payable by the underlying fund, if any, is calculated in accordance with the simplified prospectus of such underlying fund.

3. Other Fees

You may have to pay other fees when you sell or switch shares of the Fund.

FEE	WHAT YOU PAY
Switch Fee	A fee of 0-2% of the value of the shares you wish to switch may be charged by your dealer, as negotiated with your dealer.
Short Term Trading Fee	We may impose a short-term trading fee payable by the shareholder to us of up to 3% of the aggregate net asset value of the shares redeemed if such shares are redeemed within 180 days of their date of purchase or switch. For purposes of this short-term trading fee, shares will be considered to be redeemed on a first-in first-out basis.

WHAT IF I CHANGE MY MIND?

Securities legislation in some provinces and territories gives you the right to withdraw from an agreement to buy mutual funds within two business days of receiving the simplified prospectus, or to cancel your purchase within 48 hours of receiving confirmation of your order.

Securities legislation in some provinces and territories also gives you the right to cancel an agreement to buy mutual fund shares and receive your money back, or to make a claim for damages, if the simplified prospectus, annual information form or financial statements misrepresent any facts about the Fund. These rights must be exercised within the time limits set by the Securities legislation in your province or territory.
